ANNEX 1 TO DECISION NO. 9/2020 IN RELATION TO THE DEVELOPMENT OF THE CRISIS SITUATION IN THE SPREAD OF COVID-19 DISEASE CAUSED BY THE NEW CORONAVIRUS SARS-COV-2

Article 1

- 1. The new paragraph 4 is added to Article 6, which follows:
 - 4. The prohibition according to Article 6, paragraph 1 shall not apply to the personal presence of students in examinations attended by a maximum of 10 persons and to the personal presence of students in practical and clinical teaching and practice in the study of medical study programs.
- 2. The new paragraphs 8, 9, 10 and 11 are added to Article 10, which follow:
 - 8. From October 14, 2020 to November 1, 2020, providing accommodation to BUT students in accommodation facilities of BUT Halls of residence and canteens is prohibited, with the exception of students who were imposed work duties by the government pursuant to Act No. 240/2000 Coll., On Crisis Management and Amendments to Certain Acts (Crisis Act), as amended, and the students who participate in clinical and practical teaching or practice while studying medical study programs.
 - 9. The prohibition on providing accommodation in accommodation facilities of BUT Halls of residence and canteens according to the previous paragraph does not apply to BUT students who have been imposed a quarantine or isolation in connection with COVID-19 disease or are in isolation after being informed of a positive result of a COVID-19 disease test or are quarantined due to contact with a person with COVID-19 disease or a person with a positive COVID-19 test result.
 - 10. The prohibition of providing accommodation in accommodation facilities of BUT Halls of residence and Canteens also does not apply to BUT students who, for reasons worthy of special attention (especially due to the family situation), cannot be considered as students who have another residence in the Czech Republic.
 - 11. Students who are not subject to the prohibition on providing accommodation according to points 8, 9 and 10, will request the consideration of their situation by the Halls of residence and Canteen Administration at ubytovatelky@skm.vutbr.cz according to the appendix to this Annex (which is also appendix no. 2 of the decision), by sending a BUT message/BUT email via the BUT information system (messages from a private email address will not be taken into account).

Article 2 Final provisions

This Annex shall take effect on the date specified in its title.
