Registration

The Ministry of Education, Youth and Sports has registered this internal regulation pursuant to Section 36(2) of Act No.111/1998 Coll., on Higher Education Institutions and on Amendments and Additions to Other Acts (Act on Higher Education Institutions), as amended:

I. Subject of amendment

- 1. In Article 2, paragraph 1 points (a) to
 - (f) shall read as follows:
 - "a) a merit scholarship,
 - b) doctoral scholarship,
 - c) accommodation scholarship,
 - d) social scholarship,
 - e) exceptional scholarship,
 - f) a scholarship for mobility".
- 2. In Article 2, paragraphs 2 and 3 shall read as follows:
 - "2. A merit scholarship pursuant to Article 3 and a doctoral scholarship pursuant to Article 5 are awarded by the Dean of the Faculty at which the student is enrolled in the programme. Students not enrolled at any of the Faculties are awarded the merit scholarship pursuant to Article 4 and the doctoral scholarship pursuant to Article 5 on behalf of the Rector by the director of the University Institute providing the organisational aspect of the implementation of the programme.
 - 3. The accommodation scholarship pursuant to Article 6 and the social scholarship pursuant to Article 7 are awarded on behalf of the Rector by the Vice-Rector, who is entrusted with the study agenda. The accommodation scholarship pursuant to Article 6 for foreign students studying at the BUT as part of exchange, scholarship or other stays or international or European Union programs carried out on agreements, shall be granted on behalf of the Rector by the Vice-Rector who is entrusted with the foreign relations agenda."
- 3. In Article 2 paragraph 4, the first sentence reads: 'The exceptional scholarship pursuant to Article 8 and the scholarship for mobility pursuant to Article 9 are awarded by the Dean of the Faculty, the Vice-Rector entrusted with the agenda under which the scholarship is paid, or the Rector.'.
- 4. In Article 3 paragraph 1, the following words shall be inserted after the words 'academic year': 'or at a specified stage of study'.
- 5. Article 3 paragraph 4(b) reads as follows:
 - 'b) proceedings for termination of studies have been initiated'.
- 6. In Article 4 paragraph 1 in the first sentence, the following words are inserted after the words 'academic year': 'or at a specified stage of study'.
- 7. In Article 4 paragraph 3, the word "BUT" shall be replaced by: 'the University Institute providing the organisational aspect of the implementation of the programme'.
- 8. Article number '5' is replaced by article number '8'.
- 9. Articles '6 to 8' shall be replaced by '5 to 7'.
- 10. Article 5 paragraph 1 reads:
 - "1. A full-time student of a doctoral study programme shall be awarded a doctoral scholarship if the total duration of his or her doctoral study does not exceed the standard period specified for the relevant study programme. The total period of doctoral study shall include periods of previous studies in doctoral programmes completed otherwise than in accordance with Section 56(1) of the Act. The total period of doctoral study shall not include any period of interrupted study.'.
- 11. In Article 5 paragraph 3, the word "BUT" shall be replaced by: 'the University Institute providing the organisational aspect of the implementation of the programme'.
- 12. Article 5 paragraph 5(b) reads as follows:
 - "b) the disciplinary board has recommended the termination of studies on the basis of an unsatisfactory evaluation of the student in the doctoral programme".

- 13. Article 7 paragraph 2 reads as follows:
 - "2. The student shall prove his/her entitlement to the scholarship by a written certificate (issued at the student's request by the state social welfare authority which granted the allowance) stating that the student meets the conditions set out in Section 91(3) of the Act. The student may claim the scholarship only once in a given period of time."
- 14. In Article 7 paragraph 3, the following sentence is repealed:

"A student shall submit the application for a social scholarship within one month of the date of enrolment in studies, unless the contribution pursuant to section 17 of the Act No.117/1995 Coll., State Social Support, as amended, has been granted after enrolment in studies; in this case, the student may submit an application at any time during the academic year."

15. In Article 8 paragraph 1, points (e) and (f) are repealed.

The existing points (g) to (i) shall be renumbered as points (e) to (g).

16. In Article 8 paragraph 3, the following sentences are repealed:

"If the Dean decides on this scholarship, the proposal for its award shall be discussed by the Dean's Council. In the event that the Rector decides in accordance with the procedure laid down in the first sentence, he/she shall discuss the proposal of the scholarship with the members of the BUT management."

- 17. In Article 10 paragraph 3, the word "day" shall be inserted after the word "after".
- 18. In Article 10 paragraph 4, the figure '30' is replaced by figure '7'.

II. Final provisions

- This Amendment No. 1 to the Scholarship Rules of BUT was approved pursuant to Section 9(1)(b)(3) of the Act No. 111/1998 Coll. on Higher Education Institutions and on Amendments and Additions to Other Acts (Act on Higher Education Institutions), as amended, by the Academic Senate of the Brno University of Technology on 28 June 2018.
- 3. This Amendment No. 1 to the Scholarship Rules of BUT shall enter into force on the date of registration pursuant to Section 36(4) by the Ministry of Education, Youth and Sports.
- 4. This Amendment No. 1 to the Scholarship Rules of BUT shall take effect on 1 September 2018.
