Registration

The Ministry of Education, Youth and Sports has registered this internal regulation pursuant to Section 36(2) of the Act No.111/1998 Coll., on Higher Education Institutions and on Amendments and Additions to Other Acts (Act on Higher Education Institutions), as amended:

I.
Subject of amendment

The Scholarship Rules of the Brno University of Technology are amended as follows:

1. In **Article 1**, the following paragraphs 2 and 3 are inserted after paragraph 1:
 - "2. Other scholarship for reasons other than those set out in these Scholarship Rules, cannot be redeemed.
 3. The application of the Scholarship Rules cannot circumvent the provisions of Act No. 262/2006 Coll., the Labour Code, as amended, on dependent work."
2. In **Article 2 paragraph 1(a)**, the words '*under Section 91(2)(a) of the Act*' **shall be inserted** after the words 'merit scholarship'.
3. In **Article 2 paragraph 1(b)**, the words '*under Section 91(4)(c) of the Act*' **shall be inserted** after the words 'doctoral scholarship'.
4. In **Article 2 paragraph 1(c)**, the words '*under Section 91(2)(e) of the Act*' **shall be inserted** after the words 'accommodation scholarship'.
5. In **Article 2 paragraph 1(d)** the words '*under Section 91(3) of the Act*' **shall be inserted** after the words 'social scholarship'.
6. In **Article 2 paragraph 1**, a new point (e) is inserted after point (d):

"e) a scholarship under section 91(2)(b) of the Act for outstanding research, development and innovation, artistic or other creative outcomes contributing to the advancement of knowledge (hereinafter referred to as "creative scholarship"),"
7. In **Article 2 paragraph 1**, a new point (f) is inserted after new point (e), including the footnote:

"f) a scholarship under section 91(2)(c) of the Act for research, development and innovation activities under a special legal regulation⁽¹⁾,"
8. In **Article 2 paragraph 1**, the existing points (e) and (f) are renumbered points (g) and (h) and as read as follows:

"(g) an exceptional scholarship under section 91(2)(e) of the Act,
(h) the scholarship for mobility under section 91(4)(a) and (b) of the Act.

9. **Article 2 paragraph 2 reads as follows:**

"2. A merit scholarship pursuant to Article 3, a doctoral scholarship pursuant to Article 5, a creative scholarship and a scholarship for research, development and innovation under a special legal regulation pursuant to Article 8 shall be awarded by the Dean of the Faculty at which the student is enrolled in. Students who are not enrolled at any of the Faculties shall be awarded a merit scholarship pursuant to Article 4, a doctoral scholarship pursuant to Article 5, a creative scholarship and a scholarship for research, development and innovation under a special legal regulation pursuant to Article 8 by the authority of the Rector by the director of the University Institute providing the organisation of the implementation of the programme in question."

10. **Article 2 paragraph 3 reads as follows:**

"3. The scholarship pursuant to Article 6 for students in accredited study programmes and the social scholarship pursuant to Article 7 are awarded on by authority of the Rector by the Vice-Rector who is entrusted with the study agenda. The accommodation scholarship pursuant to Article 6 for foreign students coming to the BUT as part of study stays shall be granted by the Vice-Rector, who is entrusted with the foreign relations agenda, by the authority of the Rector."

11. In **Article 2 paragraph 4**, the figure '8' is replaced by figure '9' and the figure '9' is replaced by '10' in the first sentence.

12. In **Article 3 paragraph 4(b)** 'procedure for the termination has been initiated' is repealed.

13. In **Article 3 paragraph 4**, the existing points (c) and (d) shall be renumbered as (b) and (c).

14. In **Article 5 paragraph 1**, the words "carried out in the Czech language" shall be inserted after the words 'doctoral study programme' in first sentence.

15. In **Article 5 paragraph 5**, point (b) is replaced by the following:

"(b) the student's form of study has been changed from full-time to combined,"

16. In **Article 5**, the following paragraph 6 is inserted after paragraph 5:

"6. Depending on the study results achieved and the fulfilment of the individual study plan by the student of the doctoral study programme, the departmental board, on the proposal of the supervisor, may propose to the Dean or the Director of the University Institute the withdrawal of the scholarship or a change in its amount."

17. In **Article 6 paragraph 5**, the last sentence "Payments of the accommodation scholarship shall be made in arrears in four-monthly intervals, for the periods from September to December, January to April and May to August." shall be replaced by the following: "The details and deadlines for payment of the scholarship shall be laid down in an internal standard of the BUT."

18. **Article 7 paragraph 3 reads as follows:**

"3. "The social scholarship is awarded on the basis of an application by the student. Details of the details of the application for a social scholarship and the deadlines for its payment shall be determined by an internal standard of the BUT."

19. **In Article 7, paragraph 4 is repealed.**

20. **The Article 8 is inserted after Article 7:**

"Article 8

Creative scholarship and scholarship for research, development and innovation activities under a special legal regulation

1. *The creative scholarship is awarded to students of all types of study programmes for outstanding research, development and innovation, artistic or other creative activities contributing to the deepening of knowledge.*

2. *The scholarship for research, development and innovation activities under a special legal regulation is awarded to students of all types of study programmes in accordance with Act No.130/2002 Coll., on the Support of Research and Development from Public Funds and on the Amendment to Some Related Acts (the Act on the Support of Research and Development), as amended.*

3. *The creative scholarship and the scholarship for research, development and innovation activities under a special legal regulation may be awarded on the basis of a student's application and ex officio.*

4. *The final amount of the scholarship will be determined by the Dean, or in the case of scholarships for students not enrolled at any of the Faculties, by the Director of the University Institute, according to the number of students who have met the conditions for the award of the scholarship and the amount of eligible funds available."*

21. **Articles '8 to 12' are newly referred to as '9 to 13'.**

22. **Article 9 paragraph 1 reads:**

"1. An exceptional scholarship may be awarded to students of all types of study programmes:

- a) for outstanding study results,*
- b) for significant activities for the benefit of the Faculty, BUT or the academic community of the BUT,*
- c) for outstanding achievements in sport,*
- d) for outstanding artistic achievement,*
- e) for outstanding representation of BUT especially the field of science, education, sports and arts,*
- f) in case of a student's disability or difficult social situation (exceptional social scholarship),*
- g) in other cases of special consideration."*

23. In **Article 1 paragraph 15** reads as follows:

"5. In the event of a change in the facts relevant to the award, the duration or the amount of the scholarship, the awarding authority shall decide on the withdrawal or reduction of the scholarship, including during the period for which the scholarship was awarded."

24. In **Article 12**, the following **paragraph 2** shall be inserted after paragraph 1:

"2. If the student fails to provide the BUT with the bank account number for the payment of the scholarship or fails to provide other cooperation necessary for its payment within 30 days of the legal validity of the resolution awarding the scholarship, the scholarship may be withdrawn. The decision to withdraw the scholarship shall be taken by the authority which awarded the scholarship to the student."

II.

Final provisions

1. This Amendment No. 2 to the Scholarship Rules of BUT was approved by the Academic Senate of Brno University of Technology on 9 March 2021 pursuant to Section 9(1)(b) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Additions to Other Acts (Act on Higher Education Institutions), as amended.
2. This Amendment No. 2 to the Scholarship Rules of BUT shall enter into force on the date of registration under Section 36(4) of the Higher Education Institutions Act by the Ministry of Education, Youth and Sports.
3. This Amendment No. 2 to the Scholarship Rules of BUT shall take effect on the date of registration under Section 36(4) of the Higher Education Institutions Act by the Ministry of Education, Youth and Sports.
