

## ANNEX NO. 1 TO THE DEAN'S DECISION NO. 14/2020

## Schedule and conditions of participation in full-time forms of teaching in the faculty premises for teachers and students in bachelor's, master's or doctoral study programs.

- 1) The Regulation of the Extraordinary Measure of the Regional Hygienic Station of the South Moravian Region No. 2/2020 prohibits the personal presence of students at classes during university studies, with the exception of:
- a) individual visits to libraries and study rooms;
- b) individual consultations;
- c) examination in the presence of a maximum of 10 persons;
- d) laboratory, experimental or artistic work in the presence of not more than 15 persons;
- e) clinical and practical teaching and practice.
- 2) According to points 1a, 1b and 1d, the presence of students and teachers during their studies in the premises of the faculty building is possible, if necessary, in the form of studio work in the presence of a maximum of 15 people. Furthermore, if necessary, individual consultations and a visit to the library are possible. The need for full-time teaching in studios or in the form of individual consultations is at the discretion of the guarantor / teacher. In other cases, teaching must take place online.
- 3) In the case of studio teaching, for reasons of health protection and maintaining the operation of FA BUT, the presence of teachers and students in the faculty premises will be spatially distributed. The aim is to minimize the risk of transmitting a viral infection and, in the event of an infection, to reduce the number of quarantined members of the academic community. Studio teachers are assigned studio rooms, in which a maximum of 15 people will stay and, subject to other hygienic measures, as follows:

Monday: 2nd, 3rd, 4th and 5th year students are allowed to attend the studios.

Tuesday: 1st and 6th year students are allowed to attend the studios.

Wednesday: 6th year students are allowed to attend the studios.

Thursday: 2nd, 3rd, 4th and 5th year students are allowed to attend the studios.

Friday: 1st and 6th year students are allowed to attend the studios

- 4) In the event that the capacity of the allocated rooms ceases to be sufficient, or it will not be possible to comply with the required hygienic measures, the teacher will notify at any time during the vice-dean for studies.
- 5) Everyone in attendance must wear respiratory protective equipment (nose, mouth) such as a respirator, mask, mouthpiece, scarf, shawl or other equipment to prevent the spread of droplets during its duration. Upon entering the room, each of the participants will perform hand disinfection.
- 6) Respiratory protective equipment must be used when moving in all common areas of the faculty. In common areas, employees, students and other persons are also obliged to observe the maximum possible distances from other persons



## 7) Other hygiene recommendations:

- a) When staying in a classroom, try to keep distance from others.
- b) Ventilate often
- c) Try to limit the time spent by more people in one room as much as possible and do only the most necessary activities that cannot be done remotely.
